John Simms from exp Services presented to the Commission the Groundwater Flow Model conducted for the Crane Mountain Landfill. Key model findings of the study were positive.

- 2. The model was discussed as ever developing so that new data and technology could be used to improve the predictions over time and at least maintain the level of confidence.

 - a. 2017 NB Ice Storm
 - i. The Largest Emergency Response Operation in NB's History
 - ii. Assets
 - 1. 100 Fire Fighters / +230 GNB Employees
 - 2. 249 Soldiers / +308 Restoration crews
 - 3. 800 people deployed
 - 4. 40 Warming stations established
 - 5. 3 shelters set up
 - 6. 400,000 people affected
 - 7. 5 State of Local Emergency (SOLE's) declared
 - 8. 2 losses of life, 51 injuries
 - 9. Level of normalcy returned in 13 Days
 - iii. Recommendations from AAR

4) Regional Emergency Management Coordinator's Responsibilities;

- a. To maintain a liaison with Municipalities, Local Service Managers, First Responder agencies, regionally-based elements of GNB departments, GSAR Teams and other volunteer groups, NGOs, First Nation communities, Regional Service Commissions and the emergency management staff of industrial sites within their assigned Regions:
- b. To maintain overall Situational Awareness (SA) of emerging or actual incidents/emergency situations as they occur and to report to the Provincial operations centre on the response activities:
- c. To provide emergency planning and preparedness advice and assistance to stakeholder organizations, to include assisting with the design and conduct of training sessions and emergency exercises:
- d. To be prepared to activate their Regional Emergency Operations Centre(s) (REOC) as necessary to support a Municipal or Regional response to an emergency event, by providing leadership and coordination capacity to the members of the convened Regional Emergency Action Committee (REAC):
- e. To prepare and submit situation reports to the Provincial Emergency Operations Centre when activated during an emergency situation: and
- f. To be prepared to assist in the coordination of local activities during the Recovery phase of an emergency.

5) How do those Responsibilities affect you and your organization?

- a. Your REMC will:
 - i. Consult in Emergency Operations Centres Planning and Emergency Plan Development;
 - ii. Assist in exercising emergency plans;
 - iii. Provide training to your committee members;
 - iv. Be available to assist in coordination efforts during recovery efforts.
 - v. Your REMC will take municipal requests for provincial assistance
 - vi. If an emergency within a municipality escalates to the point where further powers are required
 - The Coordinator, after consultation with the Director of the New Brunswick Emergency Measures Organization, may recommend to the Mayor of the municipality that a State of Local Emergency needs to be declared.

6) All Authorities have a Responsibility for Public Safety

- a. Individual
- b. Municipal
- c. Regional
- d. Provincial
- e. National

7) Levels of Response

- a. In the <u>first</u> instance, preparing for and dealing with emergencies is the responsibility of the individual citizen.
- b. In the <u>second</u> instance, the responsibility falls with the municipality. The *Emergency Measures Act* requires each municipality to maintain a municipal EMO organization, to establish an EMO committee and to have an emergency measures plan.
- c. In a local emergency, the response structure will be based on the Municipal EMO, supported by mutual aid arrangements with neighboring Municipalities and the Regional Emergency Management Coordinator.
- d. <u>Thirdly</u>, the Municipal EMO will receive support from the REAC, who in turn will call on the PEOC for additional provincial resources.
- e. <u>Finally</u>, the Provincial Emergency Operations Centre (PEOC) will call upon the federal government or neighboring jurisdictions if required.

8) Local Authority

- a. Regardless of the level of response, responsibility for the control and conduct of the municipal emergency operations rests with the local authority.
- b. Such local authority may receive advice and assistance from the representatives of the provincial departments and agencies through the Regional Emergency Management Coordinator and/or REAC.

9) Provincial Authority

- a. The Regional Coordinator is ultimately responsible to the Director of NBEMO for the control of all operations undertaken in accordance with the plan.
- b. The Director is responsible to the Minister who in turn is responsible to the Lieutenant Governor in Council.

10) In Summary

- a. M goal for our region is Public Safety. I will follow the direction of the Director of NB EMO and I will work towards:
 - Enhancing the communications within the region to build a healthy flow of communications;
 - ii. Assist in training for the region and consult in Planning and Preparedness;
 - iii. Through that new pathway of communication, gain SA of an incident and advise the PEOC for their own SA:
 - iv. Maintain Emergency Preparedness of a REOC, coordinate REAC resources and support municipal/local resources during an emergency event;
 - v. Document the Region's Actions and submit SA reports to the PEOC;
 - vi. And finally, assist with coordination in the Recovery phase
